Warranty for Models 931 932, 933 and 952 (Rev 8/17/2005)

Intensive Use Big & Tall

For users up to 500 lbs., warrants to the original purchaser, as follows;

NOTE: See notes below about required Maintenance Agreement for Warranty to be maintained in full force.

PINNACLE SEATING, INC. warranties all non-moving parts to be free from material defects and workmanship to the original purchaser. For 10 years PINNACLE SEATING, INC. will replace any unaltered, non-moving metal components, which, based on PINNACLE examination, proves to be defective.

- For pneumatic lifts, wooden and plastic components, casters, bases, and mechanisms, the warranty is 5 years
- Fabrics: PINNACLE SEATING, INC, specifies as standard a one million double rub fabric, the fabrics have a 5-year warranty.
- COM Fabric: COM fabrics or other then specified PINNACLE SEATING, INC. standard fabric are not warranted.
- Warranty period is based upon Intensive Use environments for 24/7 shifts,
- Maintenance agreement must be signed and agreed for Warranty to remain in full force.
Maintenance agreement can either be purchased through PINNACLE SEATING, INC. and/or said Agents of PINNACLE SEATING, INC.
- Customer can provide maintenance for the agreement but must comply to PINNACLE SEATING, INC. suggested maintenance program.

The original purchaser must make all claims under this warranty within 30 days of alleged defect(s).
